To verify that you provided correct information, the Financial Aid Office will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents and submit everything to the Financial Aid Office. We reserve the right to ask you for additional information. If you have any questions about verification, contact the Financial Aid Office as soon as possible so that your financial aid will not be delayed.

In addition to the Belmont College Student, include:
